New Officers Fill Chair, Vice Chair and Secretary Treasurer Slots

The Eco Rapid Transit Board has elected three new officers who will conduct their first Board Meeting on Wednesday August 12th at 6:30 p.m. and hosted by the award winning Azalea Regional Shopping Center in South Gate.

Assuming the role of Board Chair is Councilmember Maria Davila of City of South Gate. The Board also elected City of Glendale Councilmember Zareh Sinanyan as Vice-Chair and City of Cudahy Mayor, Cristian Markovich as Secretary-Treasurer. The Board reelected City of Vernon Mayor Michael McCormick as Board Treasurer and City of Artesia Councilmember Ali Sajjad Taj as Internal Auditor.

Outgoing Board Chair, Downey Mayor Luis H. Marquez commented "I'm proud of the many accomplishments during my two-year term as Chair and I congratulate and support the new Chair, Vice Chair and Secretary as we build upon our achievements and fulfill our commitment to providing needed transportation services to our local communities.

In the North, Eco-Rapid Transit has been working to improve the corridor from Downtown Los Angeles to Bob Hope Airport. This includes the airport's new ground access plan, a new Metrolink station and pedestrian bridge. It also includes advocating for operational improvements and new transit service in the corridor.
