## Instructions/Information

Eco-Rapid Transit (also known as the Orangeline Development Authority) is seeking assistance from Consulting firms and Vendors through a Statement of Qualifications (SOQ) process in the development of a rail transit corridor serving communities from Artesia to Downtown Los Angeles and from Downtown Los Angeles to Glendale and the Hollywood Burbank Airport.

Consulting firms and Vendors on the current SOQ list that wish to submit an SOQ for any additional Professional Service Category are required to submit a new and complete SOQ package regarding the new/additional Professional Service Category. The process to submit a new SOQ can be found on the Eco-Rapid Transit website here: <http://eco-rapid.org/Records/rfp/sog/SOQcertif.final.pdf>

The updated SOQ list will be presented to the Eco-Rapid Transit Board of Directors at their January 2020 meeting, and upon Board approval, the SOQ list will be posted on the website shortly thereafter. The recertification remains valid for two-years from the date approved by the Eco-Rapid Transit Board of Directors. Consulting firms and vendors which do not submit a recertification request will be dropped from the approved SOQ list. Placement of Consulting firms and Vendors on the SOQ list does not constitute any guarantee of work.
